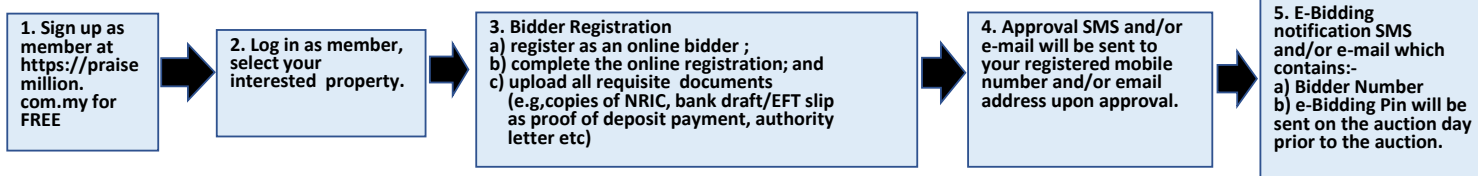

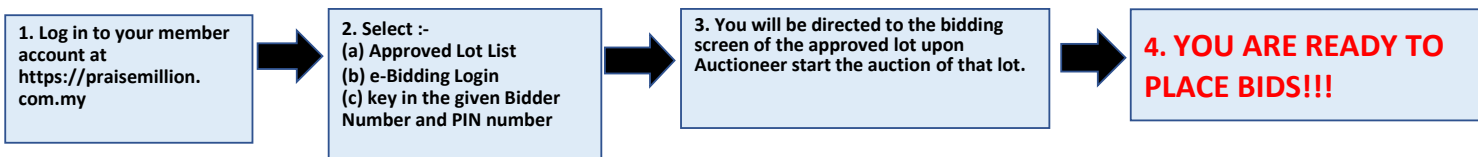

ONLINE BIDDING STEPS
