

## HONG LEONG CONNECT DAY 0% UNIT TRUST CAMPAIGN

Last update: 10 July 2023

### **ELIGIBILITY PERIOD**

The Hong Leong Bank Berhad's [193401000023 (97141-X)] ("HLB") "HLB Wealth Connect Day 0% Sales Charge Campaign" ("Campaign") commences on 01 July 2023 and ends on 21 July 2023, both dates inclusive ("Eligibility Period"), unless notified otherwise and subject to Clause 5 below.

### **TERMS & CONDITIONS**

The terms and conditions applicable to the Campaign ("T&Cs") are set out as follows:

#### **ELIGIBILITY**

- The Campaign is open to all new or existing HLB customers ("Customers") who have access to HLB Connect online services ("HLB Connect") and with at least one HLB Savings Account/HLISB (Hong Leong Islamic Bank Berhad) Savings Account-i ("SA/SA-i") who are:
  - i. Malaysian citizens; or
  - ii. Non-Malaysian citizens with Permanent Resident status in Malaysia and residing in Malaysia for more than one hundred eighty-two (182) days per calendar year;

who fulfil the following criteria ("Eligible Customers"):

- a. aged between 18 to 70 years old at the commencement of the Eligibility Period;
- b. individuals who are not U.S. persons under FATCA (Foreign Account Tax Compliance Act of U.S.); and
- subscribe to Unit Trust via HLB Connect Retail Internet Banking during the Eligibility Period.

#### **CAMPAIGN MECHANICS**

2. Under this Campaign, an Eligible Customer who subscribes to any Unit Trust in the Unit Trust funds set out in **Appendix 1** below ("**Participating Funds**") during the Eligibility Period will be entitled to 0% sales charge ("**Waiver**") in respect of the said subscription/investment provided that the amount invested on that occasion ("**Investment Amount**") is not less than the Minimum Investment Amount (as specified in **Table 1** below), and subject always to the other terms and conditions herein.

- Customers who have fulfilled the criteria under Clause 2 shall be referred to as ("Entitled Customers").
- 4. In the event the Customer's collective Investment Amount over the Eligibility Period exceeds the Maximum Investment Amount in **Table 1** above, then the amount in excess of the Maximum Investment Amount will not be entitled to the Waiver. The normal sales charge will apply to such excess amount and on any subsequent investments by that Customer. Several possible scenarios under the Campaign are set out below.



# **Campaign Scenarios**

## Scenario A:

Mr. A subscribes to Franklin U.S. Opportunities Fund (FTAM01) with an Investment Amount of RM2,500 and made his subscription via HLB Connect.

Mr. Bob subscribes to Franklin U.S. Opportunities Fund (FTAM01) with an Investment Amount of RM700 and made his subscription via HLB Connect.

#### Scenario C:

Ms. Daisy subscribes to Franklin U.S. Opportunities Fund (FTAM01) with an Investment Amount of RM6,500 and made her subscription via HLB Connect.

5. The Waiver for this Campaign is available for a Total Eligible Campaign Investment (i.e. total investments during the Campaign for which a Waiver was granted) capped at Ringgit Malaysia Seven Million Seven Hundred Thousand only (RM7,700,000) and shall be granted on a first-come-first-served basis throughout the Eligibility Period. Once the cap on Total Eligible Campaign Investment has been reached, any subsequent investment/subscription by any Entitled Customer will be subject to the normal sales charge regardless of the Minimum Investment Amount and Maximum Investment Amount in Table 1. An official announcement will be made of the stop to Waivers via the HLB Website (www.hlb.com.my) ("HLB's Website").



- 6. Investments / subscriptions via deposits from Employees Provident Fund shall not qualify for any Waiver under this Campaign.
- 7. In order to be entitled to a Waiver under the Campaign, the investments / subscriptions must be made at any time during the Eligibility Period until just before 2 p.m. on the last day of the Eligibility Period, and investments / subscriptions made after 2 p.m. on that last day will not qualify for the Waiver.
- 8. "Cooling-Off Right" is defined as the autonomy for an investor(s) to obtain a refund of his/her initial investment of the selected Unit Trust fund(s) during the Cooling-Off Period. The "Cooling-Off Period" is a grace period of not fewer than six (6) Business Days from the date that HLB received the investor's notice of intention to withdraw from the Unit Trust investment which should be received no later than the cut—off time (i.e. 2 p.m.) on a Business Day. An Entitled Customer is allowed to exercise his/her Cooling-off Right as long as the Cooling-Off Period has not expired. For the purpose of this T&C, "Business Day" means any day excluding Saturday and Sunday and gazetted Public Holidays in Malaysia on which HLB operates and is open to the public in Malaysia.

### **GENERAL**

- 9. By participating in the Campaign, the Entitled Customers agree:
  - (i) That they have read, understood and agreed to be bound by the T&Cs herein, the terms and conditions relating to HLB Connect Online Banking and HLB Connect App (where applicable ) as highlighted in the Terms and Conditions for The Use of HLB Connect (the detailed terms and conditions can be found at <a href="https://www.hlb.com.my/content/dam/hlb/my/docs/pdf/connect/hlb-tnc-en.pdf">https://www.hlb.com.my/content/dam/hlb/my/docs/pdf/connect/hlb-tnc-en.pdf</a>), the General Terms and Conditions of Accounts and the terms and conditions applicable to the relevant Unit Trust;
  - that they have read, understood and agree to be bound by HLB's Privacy Notice, which is available at HLB's Website;
  - (iii) that all records of the fulfilment of the eligibility requirement/criteria captured by HLB's system within the Eligibility Period are final;
  - that HLB's decision on all matters relating to the Campaign shall be final, conclusive and binding on the Entitled Customers;
  - (v) to access HLB's Website at regular intervals to view the T&Cs of the Campaign and ensure they are kept up-to-date on any changes or variations to the T&Cs;
  - (vi) that the gains earned/ benefit obtained from the Waiver is/are non-transferable to any third (3<sup>rd</sup>) party and non-exchangeable for up-front credit, cheque or benefit in-kind; and
  - (vii) to be liable for and shall personally bear all applicable taxes, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to their participation in the Campaign.

### 10. HLB reserves the right:

- (i) With prior notice, to add, delete, suspend or vary any or all of the T&Cs contained herein either fully or partially or terminate the Campaign by way of posting a notice on HLB's Website;
- (ii) To refuse to grant the Waiver in the event of any non-compliance by an Entitled Customer of the T&Cs herein, the General Terms and Conditions of Accounts, the terms and conditions relating to HLB Connect Online Banking and HLB Connect App (where applicable) as highlighted in the Terms and Conditions for The Use of HLB Connect ( the detailed terms and conditions can be found at <a href="https://www.hlb.com.my/content/dam/hlb/my/docs/pdf/connect/hlb-tnc-en.pdf">https://www.hlb.com.my/content/dam/hlb/my/docs/pdf/connect/hlb-tnc-en.pdf</a>) and/or the terms and conditions applicable to the relevant Unit Trust fund or detection of fraud or breach as mentioned in item (iii) below; and
- (iii) To claw-back the Waiver (i.e. require the Entitled Customer to reimburse HLB for such Waiver previously granted) in the event there is any detection of any fraud or breach of the T&Cs herein or any other terms and conditions mentioned above.



- 11. In the event of any discrepancy between the T&Cs herein and any advertising, promotional, publicity and other materials relating to or in connection with the Campaign, the final T&Cs on HLB's Website shall prevail.
- 12. Words denoting one gender include all other genders and words denoting the singular include the plural and vice versa.
- 13. The T&Cs herein shall be governed by and construed in accordance with the laws of Malaysia and the Entitled Customers agree to submit to the exclusive jurisdiction of the Courts of Malaysia.
