

## **GREEN CAR FINANCING PROMOTION**

### **PROMOTION PERIOD**

The Hong Leong Bank Berhad's (193401000023 [97141-X]) ("**HLB**") and the Hong Leong Islamic Bank Berhad's (200501009144 [686191-W]) ("**HLISB**") (hereinafter collectively referred to as "**the Bank**") "**Green Car Financing Promotion**" ("**Promotion**") commences on **16 April 2024** and ends on **30 June 2024**, both dates inclusive ("**Promotion Period**").

### **TERMS AND CONDITIONS**

The following sets out the terms and conditions applicable to the Promotion ("**T&Cs**"):

### **ELIGIBILITY**

1. The Promotion is open to all individual and non-individual customers of the Bank who have satisfied the following criteria ("**Eligible Customers**"):
  - (a) have purchased any new Tesla vehicle models sold by official Tesla Malaysia only; and
  - (b) have complied with the Promotion Mechanics below.

Non-individual Eligible Customers refer to private limited companies, public listed companies, associations, clubs, schools, societies, non-profitable organisations, sole proprietorships, partnerships, limited liability partnerships, professional practices duly registered or incorporated in Malaysia.

2. The Bank's participating products ("**Participating Products**") for this Promotion are as follows:
  - (a) Hong Leong Auto Loan Fixed Rate; and
  - (b) Hong Leong Auto Financing-i Fixed Rate.
3. The following persons are **NOT** eligible to participate in this Promotion:
  - (a) Eligible Customers who have committed or are suspected of committing any fraudulent, unlawful or wrongful acts in relation to any of the facilities (including any existing Participating Products) granted by the Bank; or
  - (b) Eligible Customers who have been declared bankrupt/wound-up (pursuant to a petition by either banks or by any third party) or are subject to any bankruptcy proceedings/winding-up proceedings at any time prior to or during the Promotion Period; or
  - (c) Eligible Customers who have committed, or determined by the Bank to be potentially committing any of the wrongful acts stipulated herein.

### **PROMOTION MECHANICS**

4. Eligible Customers must submit an application to the Bank for any of the Participating Products to finance the purchase any Tesla vehicle models during the Promotion Period.
5. All applications for the Participating Products that are successfully submitted and accepted by the Bank on or before **30 June 2024** will entitle the Eligible Customers to enjoy the following value-added benefits: -
  - i. Fast approval of the Participating Products subject to completion of documents as required by the Bank;
  - ii Preferential financing rates (case-by-case basis: tailor the rate to individual circumstances); and
  - iii Flexible repayment tenures and up to 90% margin of financing.

## **GENERAL**

6. This Promotion is **NOT** valid with any other on-going promotions offered by the Bank from time to time.

7. By participating in the Promotion, the Eligible Customers hereby:

- (a) confirm to have read, understood, and agreed to be bound by the T&Cs of the Promotion, the terms and conditions applicable to the Participating Products and the Bank's Privacy Notice which is available HLB's website at [www.hlb.com.my](http://www.hlb.com.my) and HLISB's website at [www.hlisb.com.my](http://www.hlisb.com.my) ("**Bank's Websites**");
- (b) agree to be responsible for providing the Bank with their valid and current contact details including address, mobile number and email address, and promptly notifying the Bank in the event of changes;
- (c) agree that all records of transactions captured by the Bank's system within the Promotion Period shall be final;
- (d) agree that all applications for the Participating Products are subject to the Bank's credit evaluation and approval;
- (e) consent to and authorise the Bank's usage, disclosure or publication of their personal data (i.e., name and masked ID number) for publicity, advertising or promotion purposes in any media;
- (f) agree to provide their latest and accurate contact details i.e., mobile number and addresses to the Bank. The Bank shall not be held responsible/liable in the event the Bank is unable to contact the Eligible Customers due to the inaccurate/invalid mobile numbers and/or addresses provided by the Eligible Customers
- (g) agree to be liable and shall personally bear all applicable taxes, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to their participation in the Promotion;
- (h) agree that the Bank's decision on all matters relating to the Promotion shall be final;
- (i) agree that the T&Cs herein and the terms and conditions applicable to the Participating Products shall be read together as an entire agreement. In the event of any discrepancies, the specific T&Cs herein shall prevail to the extent of such discrepancy in relation to this Promotion.
- (j) agree in the event of any discrepancies between the T&Cs herein as compared to the advertising, promotional, publicity and other materials relating to or in connection with this Promotion, the T&Cs on "**Bank's Websites**" shall prevail; and
- (k) agree to access the Bank's Websites at regular intervals to view the T&Cs and ensure to be kept up-to-date on any change or variation to the T&Cs.;

8. The Bank reserves the right:

- (a) to add, delete, suspend or vary the T&Cs contained herein, either wholly or in part at its discretion, by way of posting on the Bank's Websites or in any other matter which the Bank deems practical; and
- (b) to disqualify any of the Eligible Customers from participating in the Promotion in the event of non-compliance to the T&Cs herein.

9. The T&Cs contained herein shall be governed by and construed in accordance with the laws of Malaysia and Eligible Customers agree to submit to the exclusive jurisdiction of the Courts of Malaysia.

10. Words denoting one gender include all other genders and words denoting the singular include the plural and vice versa.
