

HONG LEONG PRIORITY BANKING REGULAR SAVINGS PLAN (RSP) PRIVILEGE CAMPAIGN

Last update: 08 February 2024

The Hong Leong Bank Berhad's [193401000023 (97141-X)] ("**HLB**" or "**Bank**") "**Hong Leong Priority Banking Regular Savings Plan (RSP) Privilege Campaign"** ("**Campaign**") commences on 08 February 2024 and ends on 31 March 2024, both dates inclusive ("**Campaign Period**"), unless notified otherwise.

TERMS & CONDITIONS

The following sets out the terms and conditions applicable to the Campaign ("T&Cs"):

<u>ELIGIBILITY</u>

- 1. The Campaign is open for participation by all individual HLB customers of the following categories ("**Eligible Customers**"):
 - a) Existing and/or new Private Banking Customers ("PV Customers"); and
 - b) Existing and/or new Priority Banking Customers ("PB Customers"),
- 2. For the purpose of this Campaign:
 - a) Asset Under Management ("AUM") refers to total deposit in any Fixed Deposit Account, Savings Account, Current Account, Foreign Currency Account and/or the Primary amount of investment in any Unit Trust ("UT") Funds and/or Structured Products with HLB at any one time. Mortgage Plus Current Account will be excluded as part of the AUM to make up the qualifying criteria.
 - b) "PB Customers" refer to customers who fulfil the qualifying criteria of Priority Banking membership ("PB Membership") which is a total AUM of Ringgit Malaysia Three Hundred Thousand (RM300,000) or such other amount as may be stipulated by HLB from time to time.
 - c) "PV Customers"_refer to customers who fulfil the qualifying criteria of PV Membership which is a total AUM of Ringgit Malaysia Three Million (RM3,000,000) or such other amount as may be stipulated by HLB from time to time.
- 3. The following persons shall not be eligible to participate in the Campaign:
 - Non-individual customers including Corporations, Business Entities, Solicitor Account Holders, Associations, Clubs, Schools, Societies, Non-profitable Organizations, Sole Proprietorships, Partnerships, Limited Liability Partnerships and Professional Practices duly registered or incorporated in Malaysia;
 - ii. Customers who have committed or are suspected of committing any fraudulent, unlawful or wrongful acts in relation to any of the facilities granted by the Bank;
 - iii. Individuals who are facing bankruptcy proceedings, or have been declared bankrupt either before, during or after the Campaign Period;
 - iv. HLB and HLISB customers who are in breach any of the General Terms and Conditions of Account and/or General Terms and Conditions of UT Accounts, at any time before or during the Campaign Period; or



- v. existing HLB and/or HLISB and/or Hong Leong Group staff.
- 4. Where there is more than one (1) person applying for the PB Membership or PV Membership, a joint account must be opened. The joint accountholder whose name appears first in the records of HLB will be the primary accountholder ("Primary Accountholder") and the other joint accountholder will be the secondary accountholder ("Secondary Accountholder"). Only the Primary Accountholder is eligible for the Promotion.

CAMPAIGN MECHANICS AND CONDITIONS

5. Subject to the terms and conditions herein, Eligible Customers who open a UT investment account with HLBB and subscribe to the selected UT as listed in Appendix 1 herein ("Selected Investments") via Regular Savings Plan ("RSP") with the minimum sum of RM8,333.34 every month for six (6) consecutive months (totalling to RM50,000) during the Promotion Period ("Criteria") will be entitled to a sales charge of 1.80% for each of the monthly UT transaction over the six (6) consecutive months ("Privilege"). Eligible Customers who fulfil the foregoing criteria shall be referred to as the "Entitled Customers".

- 6. The following UT funds are **<u>NOT</u>** eligible to participate in the Campaign:
 - i. UT funds that are 'Switched In' from other banks to HLB/HLISB;
 - ii. UT funds that are subscribed online via Hong Leong Connect Wealth; and
 - iii. UT funds that are not in the Selected Investments as listed in Appendix 1 herein.

Based on the illustration above, Mr. L is entitled to the Privilege as he fulfils the Criteria set in Clause 5 above. However, Mr B is not entitled to the Privilege as his total investment amount for the subscription of UT via RSP over six (6) consecutive months is below RM50,000.



8. The Eligible Customers may refer to their respective HLB Relationship Manager or walk-in to their nearest HLB Priority Banking Centre or HLB Branch for more information on the Campaign.

INVESTMENT PRODUCT TRANSACTIONS

- 9. Eligible Customers who wish to be entitled to the Privilege must commit to subscribe to the Selected Investments for a duration of six consecutive (6) months with a total minimum UT investment amount of Ringgit Malaysia Fifty Thousand (RM50,000) over the six consecutive (6) months, with each month's investment amount to be the same for all six (6) consecutive months.
- 10. In the event the Eligible Customers fail to meet the Criteria during the Campaign Period, HLB reserves the right to charge the Eligible Customers a sales charge of up to five percent (5%) of UT Sales Charge ("Sales Charge") on the six (6) consecutive months' transactions. The calculation of the Sales Charge shall be as follows:

Sales Charge: Principal Amount of UT Transaction x % of UT Sales Charge

- 11. For the purpose of Clause 9 above, the **Selected Funds** trade date shall be considered as the investment placement date. For the avoidance of doubt, trade date must fall within Campaign Period.
- 12. Investments in the selected UT Funds in Selected Investments using funds withdrawn from the Employees Provident Fund ("**EPF**") are not allowed to participate in this Campaign.
- 13. In the event the Eligible Customers exercise their UT cooling-off right or any transaction of the Selected Funds is rejected or cancelled by any parties for whatsoever reason, Eligible Customers shall **NOT** be entitled to the Privilege.
- 14. The terms and conditions governing the UT transactions and products of the selected UT funds under Selected Investments are specified in the relevant latest Prospectus(es) and Supplemental Prospectus(es) thereto (if any) that have been duly registered and approved by the Securities Commission Malaysia which shall be governed by and regulated in accordance with the Capital Markets And Services Act 2007 (as amended) and the relevant guidelines and directives issued by the relevant authorities.

GENERAL TERMS AND CONDITIONS

- 15. By participating in this Campaign, the Eligible Customers:
 - i. confirm that they have read and understood the T&Cs and agree to be bound by the T&Cs herein and any other terms and conditions that the Bank may impose from time to time by way of notice;



- ii. agree that the Bank's decisions on all matters regarding the Campaign shall be final, conclusive and binding on all Eligible Customers;
- iii. agree that the T&Cs herein, Priority Banking Terms and Conditions/Private Banking Terms and Conditions, General Terms and Conditions of UT Accounts, the General Terms and Conditions of Accounts and the terms and conditions governing the transactions in the Selected Investments shall be read as an entire agreement. Should there be any discrepancy, the specific T&Cs herein shall prevail to the extent of such discrepancy; and
- iv. agree to access the Campaign Website https://www.hlb.com.my/en/personal/banking/promotions.html ("Campaign Website") at regular intervals to view the T&Cs of the Campaign and to ensure they keep up-todate with any changes or variations to the T&Cs;
- v. agree to be liable and shall personally bear all applicable taxes, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to their participation in this Campaign.
- 16. The Bank reserves the right:

 - ii. disqualify any of the Eligible Customers as the Bank may in its discretion to participate in the Campaign; and
 - iii. forfeit the Privilege in the event of non-compliance by the Eligible Customers of any of the T&Cs herein, the General Terms and Conditions of UT Accounts and all other laws/rules applicable.

 - i. the accountholder(s) (whether individually or jointly) of the UT investment account must be of the same individuals as the accountholders of the PV Membership or PB Membership; and
 - ii. UT funds can only be purchased under the name of the Primary Accountholder.
- 18. In the event of any discrepancies between the T&Cs as compared to the advertising, promotional, publicity and other materials relating to or in connection with this Campaign, the latest T&Cs on the Campaign Website shall prevail.
- 19. The T&Cs herein shall be governed by and constructed in accordance with the laws of Malaysia and the Eligible Customers agree to submit to the jurisdiction of the Courts of Malaysia.
- 20. Words denoting one gender include all other genders and words denoting the singular include the plural and vice versa.
