

HONG LEONG BANK UNIT TRUST WITH FIXED DEPOSIT (UTFD) CAMPAIGN

Last update: 10 July 2024

ELIGIBILITY PERIOD

The Hong Leong Bank Berhad's (193401000023 (97141-X)) ("HLB") "HLB Unit Trust with Fixed Deposit (UTFD) Campaign" ("Campaign") commences on 15 July 2024 and ends on 30 September 2024, both dates inclusive of ("Eligibility Period"), unless notified otherwise.

TERMS & CONDITIONS

The following sets out the terms and conditions applicable to the Campaign ("T&Cs"):

ELIGIBILITY

1. This Campaign, is open to all HLB customers including Malaysian and non-Malaysian individuals ("Eligible Customers").

PARTICIPATION DETAILS

- 2. The following UT funds are **NOT** eligible to participate in the Campaign:
 - UT funds that are 'Switched In' from other banks to HLB/HLISB are not eligible for this Campaign;
 - ii. UT funds that are subscribed online via Hong Leong Connect Wealth;
 - iii. UT funds that are not in the Participating Funds list (refer Appendix 1).

CAMPAIGN MECHANICS

- This Campaign enables the Customers to obtain Promotional FD Rates for the Participating FD Accounts as defined in Clause 4 below upon investing a Minimum UT Investment Amount.
- 4. The participating Fixed Deposit ("FD") accounts ("Participating FD Accounts") for this Campaign are as follows:
 - (a) Conventional FD;
 - (b) Senior Savers Flexi FD:
 - (c) Priority Banking Premium FD; and
 - (d) Junior FD.
- 5. To participate in this Campaign and to qualify for the Promotional FD Rate as set out in Table 1 below, the Customers shall during the Campaign Period:
 - i. invest a Minimum UT Investment Amount of Ringgit Malaysia Twenty Thousand (RM20,000) ("Minimum UT Investment Amount") in any of the selected Unit Trust Fund ("UT") (refer to Appendix 1), subject to payment of a Minimum UT Sales Charge (as defined in Table 1 below); and
 - ii. open any of the Participating FD Accounts with HLB (if the Customers do not have one prior to the Campaign Period) and place/deposit a Maximum FD Placement Amount i.e. any amount up to the UT Investment Amount, into the Participating Accounts ("FD Placement Amount").
- 6. Customers who fulfil Clause 5 above in accordance with the requirements set out in Table1 below shall be known as "Eligible Customers". Deposit made in the form of Regular Savings Plan ("RSP") instead of a single transaction is not allowed for this particular Campaign.

Should there be an Overnight Policy Rate (OPR) change, HLB reserves the right to revise the Promotional FD Rates.

7. For the avoidance of doubt, Table 2 illustrates the permissible FD Placement Amount based on the criteria in Table 1 above.

- 8. Based on Table 2 above, the Minimum UT Investment Amount for the Eligible Customer is Ringgit Malaysia Twenty Thousand (RM20,000). The Customer will be eligible to deposit/place a Maximum FD Placement Amount i.e any amount up to Ringgit Malaysia Twenty Thousand (RM20,000) only in their Participating FD Accounts for the Promotional FD Rate offered.
- The UT order date shall be considered as the UT Investment date for the selected UT products listed in Appendix 1.
- 10. The FD Placement Amount deposited into the Participating FD Accounts must be made within seven (7) days from the UT investment date. Both UT Investment & FD placement must be made within the Campaign Period.
- 11. The fund size limit for the Promotional FD Rates is Ringgit Malaysia Twenty Million (RM20,000,000) ("**Fund Size Limit**"), subject to first-come, first-served basis.
- 12. Promotional FD Rate is applicable for **New Funds** only.
- 13. New Funds are defined as Cash, Financial Process Exchanges ("FPX"), instant transfer, interbank GIRO, new funds received via telegraphic transfer from other banks, local cheque or banker's cheque issued by other banks which are deposited into HLB Current Account or Savings Account ("CASA") of the Eligible Customers before depositing the said fund into the Participating FD Accounts;



- 14. The following shall **NOT** be considered as "New Funds":
 - i. maturing FD or premature withdrawal of FD from any existing FD Accounts with HLB;
 - ii. intra bank transfer of funds, i.e., transfer of funds from another HLB account (whether CASA, FD or General Investment Account); and
 - iii. inter and/or intra branch transfer within HLB including by third party account transfer;
 - iv. proceeds arising from the redemption of equity, unit trust funds, bonds / sukuk and / or another HLB FD accounts during the Campaign Period that are re-deposited into the Participating FD Accounts;
 - v. any proceeds from the Employees Provident Fund ("**EPF**").
- 15. This Campaign is NOT valid with any other on-going promotions offered by HLB from time to time.
- 16. Each Eligible Customer is entitled to one (1) Promotional FD Rate per UT Investment made.
- 17. The Eligible Customer shall be the primary accountholder or the secondary accountholder for the Participating FD Account and the UT Investment Account
- 18. In the event any FD Placement Amount exceeds the prescribed Maximum FD Placement Amount as set out in Table 1 above or if the Fund Size Limit is reached, then such FD Placement Amount shall be subject to the prevailing FD board rates as determined by the Bank.
- 19. The Eligible Customers who do not have any CASA prior to the Campaign Period are required to open one and nominate a CASA maintained with HLB under the same name and signature requirement as the Participating FD Account ("Nominated CASA") for the purpose of crediting the interest earned under this Campaign.
- 20. The interest earned for the Participating FD Accounts shall be credited into the Eligible Customers' Nominated CASA at maturity.
- 21. Upon maturity, the Participating FD Accounts belonging to the Eligible Customers shall be auto-renewed at the prevailing FD board rates and the interest earned will be credited into the Eligible Customers' Nominated CASA at maturity.
- 22. No interest shall be payable on partially withdrawn amounts and premature withdrawals of the FD, regardless of the number of completed months at the time of premature withdrawal and the final balance of the Participating FD Account.
 - Subject to Clause 22 above, partial withdrawal of the FD is allowed in multiples of **Ringgit Malaysia One Thousand (RM1,000)** only.
- 23. FD Placement Amount deposited into the Participating FD Accounts for the purpose of this Campaign shall not be used as collateral for the purpose of securing any credit facility obtained or to be obtained. This does not apply to other FDs and/or Conventional FDs which can be used as collateral to secure the credit card(s) (i.e. issued by HLB). Please refer to the Secured Credit Card with Fixed Deposit Terms & Conditions for more information.
- 24. In the event the Eligible Customers exercise their cooling-off right or any transaction of the UT Investment is rejected or cancelled by any parties for whatsoever reason, Eligible Customers shall NOT be entitled to the Promotional FD Rate as stipulated in Tables 1 and 2 above. Accordingly, the funds placed/deposited in the Participating FD Account will be



uplifted and no interest shall be paid according to clause 23 above.

GENERAL

- 25. By participating in the Campaign, the Eligible Customers:
 - confirm that they have read, understood and agreed to be bound by the T&Cs herein; General Terms and Conditions of Accounts, terms and conditions applicable to the Participating FD Accounts;
 - ii. agree that all records of the fulfilment of the eligibility requirements captured by HLB's system within the Campaign Period are final and conclusive;
 - iii. agree that HLB's decision on all matters relating to the Campaign shall be final, conclusive and binding on the Eligible Customers;
 - iv. agree to access HLB's websites at (www.hlb.com.my) ("HLB's Website") at regular intervals to view the T&Cs of the Campaign and ensure to be kept up-to-date on any changes or variations to the T&Cs; and
 - v. agree to be liable and shall personally bear all applicable taxes, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to their participation in the Campaign.

26. HLB reserves the right:

- With prior notice to the Customers, to add, delete, suspend or vary any or all of the T&Cs contained herein either fully or partially or to terminate the Campaignby way of posting on HLB's Website, or in any other manner which HLB deemed practical;
- ii. To forfeit the interest earned in the event of non-compliance by the Eligible Customers of the T&Cs herein, General Terms and Conditions of Accounts, terms and conditions applicable to the Participating FD Accounts and terms and conditions of the Nominated CASA; and
- iii. To claw-back the interest paid in the event there is any detected fraud.
- 27. The T&Cs herein, General Terms and Conditions of Accounts, terms and conditions applicable to the Participating FD Accounts shall be read as an entire agreement. In the event of any discrepancy between the T&Cs herein in relation to the Campaign, General Terms and Conditions of Accounts, terms and conditions applicable to the Participating FD Accounts, the T&Cs herein shall prevail to the extent of such discrepancy.
- 28. In the event of any discrepancy between the T&Cs herein and any advertising, promotional, publicity and other materials relating to or in connection with the Campaign, the final T&Cs on HLB's Website shall prevail.
- 29. The T&Cs shall be governed by and construed in accordance with the laws of Malaysia and the Eligible Customers agree to submit to the exclusive jurisdiction of the Courts of Malaysia.
- 30. Words denoting one gender include all other genders and words denoting the singular include the plural and vice versa.
