

# HONG LEONG BANK UNIT TRUST FIXED DEPOSIT (UTFD) CAMPAIGN

Last update: 09 January 2025

#### **ELIGIBILITY PERIOD**

The Hong Leong Bank Berhad's (193401000023 (97141-X)) ("HLB") "HLB Unit Trust Fixed Deposit (UTFD) Campaign" ("Campaign") commences on 06 January 2025 and ends on 31 March 2025, both dates inclusive of ("Eligibility Period"), unless notified otherwise.

### **TERMS & CONDITIONS**

The following sets out the terms and conditions applicable to the Campaign ("T&Cs"):

# **ELIGIBILITY**

- 1. The **Campaign** is open for participation to HLB's Existing and New customers, both Malaysian and Non-Malaysian citizens.
- 2. For the purpose of this Campaign:
  - a) **New Customers** refer to individual primary accountholders who do not have any accounts or investments with HLB prior to the Campaign Period.
  - b) **Existing Customers** refer to individual primary accountholders who have opened a current/savings account prior to the Campaign Period.
- 3. The following persons shall not be eligible to participate in the Campaign:
  - a) Customers who have committed or are suspected of committing any fraudulent, unlawful or wrongful acts in relation to any of the facilities granted by HLB;
  - b) Individuals who are facing bankruptcy proceedings, or have been declared bankrupt either before, during or after the Campaign Period;
  - c) HLB and HLISB customers who are in breach any of the General Terms and Conditions of Account and/or General Terms and Conditions of unit trust UT Accounts, at any time before or during the Campaign Period; or
  - d) Existing HLB and/or HLISB and/or Hong Leong Group staff.

# **CAMPAIGN MECHANICS**

- 4. This Campaign enables the Customers to obtain Promotional FD Rates for the Participating FD Accounts as defined in Clause 5 below and subject to the Campaign Mechanics stated in this T&Cs being fulfilled.
- 5. The participating Fixed Deposit ("**FD**") accounts ("**Participating FD Accounts**") for this Campaign are as follows:
  - a) Conventional FD;
  - b) Senior Savers Flexi FD:
  - c) Priority Banking Premium FD; and
  - d) Junior FD.
- 6. To participate in this Campaign and to qualify for the Promotional FD Rate as set out in Table 1 below, the Customers shall during the Eligibility Period:-



- a) invest a minimum sum of Ringgit Malaysia Twenty Thousand (RM20,000) ("Minimum UT Investment Amount") in any of the selected Unit Trust Fund as stated in Appendix 1 ("Selected UT"), subject to payment of a Minimum UT Sales Charge as defined in Table 1 below; and
- b) open any of the Participating FD Accounts with HLB (if the Customers do not have one prior to the Campaign Period) and place/deposit an amount not exceeding the Maximum FD Placement Amount as defined in **Table 1** below, into the Participating Accounts ("**FD Placement Amount**").
- 7. Customers who fulfil Clauses 6 above in accordance with the requirements set out in Table 1 below shall be known as "Eligible Customers". Deposit made in the form of Regular Savings Plan ("RSP") instead of a single transaction is not allowed for this Campaign.

Should there be an Overnight Policy Rate (OPR) change, HLB reserves the right to revise the Promotional FD Rates.

8. For the avoidance of doubt, **Table 2** illustrates the Maximum FD Placement Amount based on the criteria in **Table 1** above.

- 9. Based on **Table 2** above, the Eligible Customer meets the Minimum UT Investment Amount by investing RM20,000 in one of the Selected UT during the Promotional Period, As a result, the Eligible Customer is eligible to deposit/place any amount up to RM20,000 only in the Participating FD Accounts for a 3 months tenure at the Promotional FD Rate of 4.68% p.a.
- 10. The UT order date shall be considered as the UT Investment date for the Selected UT funds listed in Appendix 1.
- 11. The FD Placement Amount deposited into the Participating FD Accounts must be made within seven (7) working days from the UT investment date. Both UT Investment & FD placement must be made within the Campaign Period.



- 12. The fund size limit for the Promotional FD Rates is **Ringgit Malaysia Twenty-Eight Million (RM28,000,000)** ("**Fund Size Limit**"), subject to first-come, first-served basis.
- 13. Promotional FD Rate is applicable for FD placement made with **New Funds** (as defined in Clause 14 below) only.
- 14. For the purpose of this Promotion, the following are considered as New Funds:
  - a) Cash, Financial Process Exchanges ("**FPX**"), instant transfer, interbank GIRO, new funds received via telegraphic transfer from other banks; and
  - b) local cheque or banker's cheque issued by other banks

which are deposited into HLB Current Account or Savings Account ("CASA") of the Eligible Customers before depositing the said fund into the Participating FD Accounts.

- 15. The following shall **NOT** be considered as "**New Funds**":
  - a) maturing FD or premature withdrawal of FD from any existing FD Accounts with HLB:
  - b) intra bank transfer of funds, i.e., transfer of funds from another HLB account (whether CASA, FD or General Investment Account); and
  - c) inter and/or intra branch transfer within HLB including by third party account transfer;
  - d) proceeds arising from the redemption of equity, unit trust funds, bonds / sukuk and / or another HLB FD accounts during the Campaign Period that are redeposited into the Participating FD Accounts;
  - e) any withdrawals from the savings pursuant to the Employees Provident Fund Act 1991.
- 16. This Campaign is NOT valid with any other on-going promotions offered by HLB from time to time.
- 17. Each Eligible Customer is entitled to one (1) Promotional FD Rate per UT Investment made
- 18. The Eligible Customer shall be the primary accountholder or the secondary accountholder for the Participating FD Account and the UT Investment Account.
- 19. In the event any FD Placement Amount exceeds the prescribed Maximum FD Placement Amount as set out in Table 1 above or if the Fund Size Limit is reached, then such FD Placement Amount shall be subject to the prevailing FD board rates as determined by HLB.
- 20. The Eligible Customers who do not have any CASA prior to the Campaign Period are required to open one and nominate a CASA maintained with HLB under the same name and signature requirement as the Participating FD Account ("Nominated CASA") for the purpose of crediting the interest earned under this Campaign.
- 21. The interest earned for the Participating FD Accounts shall be credited into the Eligible Customers' Nominated CASA upon maturity.



- 22. Upon maturity, the Participating FD Accounts belonging to the Eligible Customers shall be auto-renewed at the prevailing FD board rates and the interest earned will be credited into the Eligible Customers' Nominated CASA.
- 23. No interest shall be payable on partially withdrawn amounts and premature withdrawals of the FD, regardless of the number of completed months at the time of premature withdrawal and the final balance of the Participating FD Account.
  - Subject to Clause 23 above, partial withdrawal of the FD is allowed in multiples of **Ringgit Malaysia One Thousand (RM1,000)** only.
- 24. FD Placement Amount deposited into the Participating FD Accounts for the purpose of this Campaign shall not be used as collateral for the purpose of securing any credit facility obtained or to be obtained. This does not apply to other FDs and/or Conventional FDs which can be used as collateral to secure the credit card(s) (i.e. issued by HLB). Please refer to the Secured Credit Card with Fixed Deposit Terms & Conditions for more information.
- 25. In the event the Eligible Customers exercise their cooling-off right or any transaction of the UT Investment is rejected or cancelled by any parties for whatsoever reason, Eligible Customers shall NOT be entitled to the Promotional FD Rate as stipulated in Table 1 above. Accordingly, the funds placed/deposited in the Participating FD Account will be uplifted and no interest shall be paid according to clause 23 above.

#### **GENERAL**

- 26. By participating in the Campaign, the Eligible Customers:
  - a) confirm that they have read, understood and agreed to be bound by the T&Cs herein; General Terms and Conditions of Accounts, terms and conditions applicable to the Participating FD Accounts, and any other other relevant terms and conditions that HLB may impose from time to time by way of notice to the Customers;
  - b) agree that all records of the fulfilment of the eligibility requirements captured by HLB's system within the Campaign Period are final and conclusive;
  - c) agree that HLB's decision on all matters relating to the Campaign shall be final, conclusive and binding on the Eligible Customers;
  - d) agree to access HLB's websites at (<u>www.hlb.com.my</u>) ("**HLB's Website**") at regular intervals to view the T&Cs of the Campaign and ensure to be kept up-todate on any changes or variations to the T&Cs;
  - e) agree that benefit(s) obtained from the Campaign is/are non-transferable to any third (3<sup>rd</sup>) party and non-exchangeable for up-front credit, cheque or benefit in-kind; and
  - f) agree to be liable and shall personally bear all applicable taxes, government fees or any other charges that may be levied against them under applicable laws, if any, in relation to their participation in the Campaign.

#### 27. HLB reserves the right:

- a) With prior notice to the Customers, to add, delete, suspend or vary any or all of the T&Cs contained herein either fully or partially or to terminate the Campaign by way of posting on HLB's Website, or in any other manner which HLB deemed practical;
- b) To forfeit the interest earned in the event of non-compliance by the Eligible Customers of the T&Cs herein, General Terms and Conditions of Accounts,



- terms and conditions applicable to the Participating FD Accounts and terms and conditions of the Nominated CASA; and
- c) To claw-back the interest paid in the event there is any detected fraud.
- 28. The T&Cs herein, General Terms and Conditions of Accounts, terms and conditions applicable to the Participating FD Accounts shall be read as an entire agreement. In the event of any discrepancy between the T&Cs herein in relation to the Campaign, General Terms and Conditions of Accounts, terms and conditions applicable to the Participating FD Accounts, the T&Cs herein shall prevail to the extent of such discrepancy.
- 29. In the event of any discrepancy between the T&Cs herein and any advertising, promotional, publicity and other materials relating to or in connection with the Campaign, the final T&Cs on HLB's Website shall prevail.
- 30. The T&Cs shall be governed by and construed in accordance with the laws of Malaysia and the Eligible Customers agree to submit to the exclusive jurisdiction of the Courts of Malaysia.
- 31. Words denoting one gender include all other genders and words denoting the singular include the plural and vice versa.
